Resolution No. 2001-01
Resolution Establishing Ward Boundaries
Based on 2000 Census Data

WHEREAS, the Town of Stockbridge has received 2000 census data and is required to establish ward boundaries based on the figures provided.

WHEREAS, the Calumet County Board has adopted a tentative redistricting plan and the next step is for the Town of Stockbridge to report ward boundaries and ward numbers.

NOW THEREFORE, BE IT RESOLVED by the Town Board of Stockbridge, that the following wards are established:

WARD ONE: All the territory located within the following boundaries to-wit: Commencing at the intersection of the east town boundary line and Faro Springs Road, thence running west along the centerline of Faro Springs Road to the shore of Lake Winnebago, thence south along the shore of Lake Winnebago to the north boundary of the Village of Stockbridge, thence east and south along the Village of Stockbridge village limits to the centerline of County Trunk E, thence east to the east town boundary line, thence north along the east town boundary line to the point of beginning, shall constitute the First Ward.

WARD TWO: All the territory located within the following boundaries to-wit: Commencing at the intersection of County Trunk E and the east town boundary line, thence west along the centerline of County Trunk E to the Village of Stockbridge village limits, thence south and west along the Village of Stockbridge village limits to the shore of Lake Winnebago, thence south along the shore of Lake Winnebago to the south town boundary line, thence east along the south town boundary line to the intersection of County Highway C, thence north along the centerline of County Highway C. to the intersection of County Truck F, thence east along the centerline of County Truck F to the east town boundary line, thence north along the east town boundary line to the point of beginning, shall constitute the Second Ward.

WARD THREE: All the territory located within the following boundaries to-wit: Commencing at the intersection of County Trunk F and the east town boundary line, thence west along the centerline of County Trunk F to the intersection of County Highway C, thence south along the centerline of County Highway C to the south town boundary line, thence east along the south town boundary line to the intersection of the east town boundary line, thence north along the east town boundary line to the point of beginning, shall constitute the Third Ward.

FURTHER BE IT RESOLVED that Wards 1 & 2 in the Town of Stockbridge will constitute part of Calumet County Supervisory District No. 15, and Ward 3 in the Town of Stockbridge will constitute part of Calumet County Supervisory District No. 16.

FURTHER BE IT RESOLVED that the polling place for all wards will be at the Community Hall in the Village of Stockbridge, WI.

FURTHER BE IT RESOLVED returns shall be maintained only for the group of combined wards at any election except elections involving Calumet County Supervisory Districts.

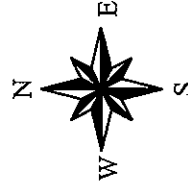
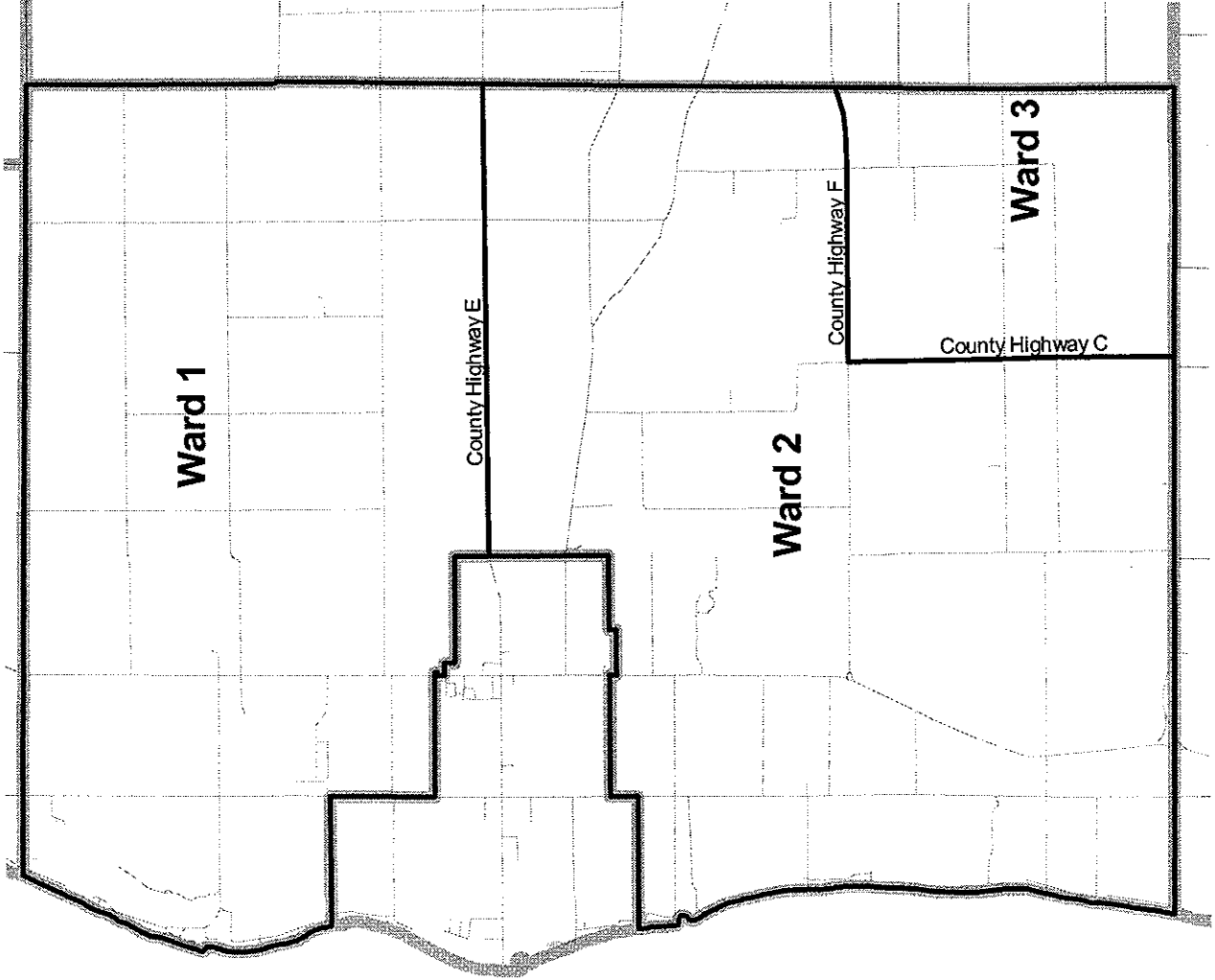
