Five people signed up to speak.

Mark moved and Dean 2nd to approve the agenda. Motion carried.

Item: Minutes Jan. 23, 2020. Mark 1st and Dean 2nd to approve as presented. M/C

Item 7: Dean Joas spoke about the slant of the roof should require a re-bid and suggested re-bidding due to none of the bids addressing this issue. Nick Thomas from SPS Roofing spoke about his bid and options to receive his help in drafting the bid invitation package. Mark moved and Dean 2nd to re-bid the roof project. Ken abstained from the vote. Nick Thomas and Erik Waisanen of SPS roofing left the meeting at 7:17 PM.
