Clerk Steve indicated the meeting has been properly posted.

Dean Joas moved and Mark Ecker 2<sup>nd</sup> to approve the meeting minutes of Saturday, September 12, 2020. M/C.

Ken updated the board on the status of Moehrke Road as well as the other road/construction projects.

Steve shared an upcoming preliminary CSM in Gov. Lot 323 for Anna Pitak. Application for approval will be coming in the future. Dean inquired about limits of subdividing. No action taken.

Website upgrade: After discussion about logo design. Dean moved to accept the proposal from the current vendor to upgrade the website and use a sturgeon logo similar to the one used on the fire trucks. Mark  $2^{nd}$  and M/C.

Treasurer's report: Dean moved and Mark 2<sup>nd</sup> to approve the report. M/C.

Bills approval and payment: Mark moved and Dean 2<sup>nd</sup> to approve the bills as presented to the board. M/C.
