Judy Hartl called for nominations for candidates to Town Supervisor. Dean Joas (8)was nominated by Marvin Woelfel and 2<sup>nd</sup> by Ken Schaefer. Mark Ecker (14) was nominated my Maurice Ecker and seconded by Check Ecker. Jim Hooyman (14)was nominated by Josh Woelfel and 2<sup>nd</sup> by Chuck Ecker. Joe Kuhn (15) was nominated by Mark Ecker and John Groeschl 2<sup>nd</sup> the nomination. Adam Ecker (11) was nominated by John Groeschl and 2<sup>nd</sup> by Maurice Ecker. No other nominations were offered after 3 calls and Chuck Ecker moved and Joe Kuhn moved to close

nominations. Seeing 5 nominated candidates and only 4 ballot positions available a vote via paper ballot was called. Judy Hartl gathered the ballots and Andrea Ortlieb tallied the votes and the counts were as indicated by the number in parathesis after their name. The four highest nominees will appear on the ballot on April 6, 2021 as decided at the caucus.
