Town Board Meeting Minutes 7:00 PM July 10, 2024

Chairman Joe Kuhn called the meeting to order at 7:00 PM. Present were Supervisors Mark Ecker, Clerk Steve Phipps, Treasurer Andrea Ortlieb, Road Supervisor Mark Tasch, Residents: Gary Ricker\*, Jennifer Nadler-Lont and Ralph Schmid. \*Signed up for public comment.

Steve confirmed the meeting notices were posted.

Public comments: Gary Ricker expressed concerns about water backing up and/or blocked culverts on Mud Creek Road and Lakeshore Drive from the recent rains.

Roads, Buildings and Equipment: Mark T. reported that all culverts have been changed for this year's paving projects. Trees in the right-of-way will be cleaned as time permits as the storms have been keeping everyone busy. Ditches are being cut again. Mayflower Lane: It was reported a ½ mile stretch of the road was under water for 6 hours and Mark T suggested adding additional culverts on the south with an estimated cost of \$7,000.00 and on the north costing an estimated cost of \$5500.00. Joe tabled the matter until September.

Mud Creek Road: Mark T. noted that the culverts are old and will need to replaced sometime in the future. Joe asked Mark T. to clean the area as good as possible to help the water flow.

No update on chip sealing as the weather has been causing delays.

CSM: Martha Thiel's application was reviewed. Joe moved to approve with no comment. Mark E.  $2^{nd}$ . M/C.

Wind ordinance: Joe reported there in no information to review and he has not been able to meet with the town's attorney.

Liquor License applications: Derek Kwidzinski, DBA Shanty Bar and Grill, LLC, applied for a class B combination liquor license. After review, Joe moved to issue the license, Mark E. 2<sup>nd</sup>. M/C. Quinney Fishing Club applied for a temporary class B license. After review, Joe moved to issue the license, Mark E. 2<sup>nd</sup>. M/C.

Communications: Steve reported that WL Insulation did a nice job repairing the leak around the chimney in the rental house. No invoice has been issued despite Steve stopping to ask for one. The letter sent to the owner of record on the old motel was returned as undeliverable. Paul and Ann Kaestner reported on how nice and reasonable Eric Buechel was to work with to get rid of unwanted brush/yard waste.

Treasurer's Report: Joe moved to approve the report. Mark E 2<sup>nd</sup>. M/C.

Payment of bills: Mark E. moved to approve payment of all bills presented to the board. Joe  $2^{nd}$ . M/C.
